PRESIDENT'S THOUGHTS

At the latest board meeting in East Peoria in June, Bev informed the board of a recent development in Texas that should bring concern to every licensed plumber in Illinois. The Texas legislature recently eliminated their state plumbing license law/program as of September 1, 2019. After many contacts, rallies, and lobbying efforts by the PHCC of Texas, Governor Greg Abbott signed an Executive Order authorizing a two year extension. The Texas legislature adjourned in May and only convenes every two years. Having this extension gives the PHCC of Texas the opportunity to work with legislators to hopefully restore and strengthen the law when they return in 2021.

This brings us to Illinois. In the past there have been attacks on our licensing law and code. If a state the size of Texas (with many times the number of licensed plumbers that Illinois has) can have this done to them, so can Illinois. We need to be vigilant about protecting what we have. We need to step up and help those (Illinois PHCC & IMSCA) that can help us.

We can do this by 1) responding when they need help with contacting/talking with our local politicians, and 2) funding both these organizations to enable them to represent us.

PLUMBING CONTRACTOR REGISTRATION RENEWAL TIME

All plumbing contractors registered with the Illinois Department of Public Health should receive a renewal post card in mid-August. Even though you are renewing online, you must still fax **or** email the insurance and bonds. **Only send those documents by ONE of these methods.** Do **NOT** email and then follow up with a fax. This only causes confusion and delays the process. IDPH highly **recommends emailing**, rather than faxing.

Display Restrictions: All products, services, or literature displayed must fit within the allotted 8' x 10' booth space. Exhibits may not project beyond the space allotted or interfere with traffic, other exhibits, including line of sight. Exhibits may not extend into any aisle. Management reserves the right without recourse to prohibit any portion of any exhibit, which in its opinion is not suitable, or in keeping with the character of the event. This reservation of rights by Management applies to persons, things, conduct, printed matter, catalogs, and any other material relating to or affecting the event. No signs, banners, or flyers may be displayed or distributed outside of assigned booth space. TEXAS GOVERNOR SIGNS EXECUTIVE ORDER EXTENDING BOARD OF PLUMBING EXAMINERS

On Thursday, June 13, Texas Governor Greg Abbott signed an Executive Order authorizing a two-year extension of the Texas State Board of Plumbing Examiners (BPE), essentially overturning the state legislature's abolishment of the board in late May 2019. The Executive Order "prevents the imminent abolition of the Texas State Board of Plumbing Examiners and expiration of the Plumbing License Law on September 1, 2019, and delay[s] that abolition and expiration until disaster needs subside or the 87th legislature addresses the matter. To facilitate the legislature's consideration of the issue, this suspension shall have the force and effect of law until May 31, 2021."

PHCC is grateful for Gov. Greg Abbott's intervention and looks forward to working with PHCC of Texas to ensure a long-term solution. The PHCC of Texas, which worked diligently over the past few months to help influence continued state oversight of plumbing licensure in Texas, praised the governor's action by stating: "This option maintains the plumbing certifications and licenses necessary to preserve the health, safety and well-being of all Texans."

Gov. Abbott's action followed the Texas State Legislature's failure on May 26, 2019, to take legislative action that would have preserved the Texas State BPE. As a result, the BPE would have ceased issuing plumbing licenses on September 1, 2019, and completely shut down effective September 1, 2020, had the governor not signed the executive order or otherwise reconvened the

legislature. Had Texas allowed the BPE to expire, responsibility of issuing plumbing licenses and regulating the plumbing industry would have fallen to the state's local governments and municipalities. The city of San Antonio had already initiated steps to adopt its own standards prior to the issuance of the executive order. 🇺🇸

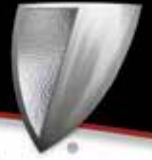

Mobile Device Distraction Is Not Just a Road Problem

Whether on an active construction site, on a fast-paced manufacturing floor, or in any situation where several activities are taking place simultaneously, attention from everyone is key to helping keep a work environment safe.

Distractions on the job can have catastrophic consequences. And while distractions are all around, there is one type that can be easily eliminated: mobile devices.

The Myth of Multitasking

Safety-minded businesses generally take the necessary step of prohibiting mobile device use while operating machinery or while in areas where potentially hazardous activities are taking place. But without providing context, you run the risk of an employee ignoring the rule and causing an otherwise preventable disaster.

Tell your employees this simple fact: People cannot multitask. Sure, the human brain can switch swiftly from task to task. However, it can't focus on more than one task at a time, even though it appears that way to an outside observer.

Imagine a forklift moving a heavy load through a warehouse. The driver can be doing everything correctly — sounding the horn at intersections, driving at a reasonable speed, scanning his or her path for obstructions, etc. — but if other people in the area have their heads down, reading a text message or checking the weather, there's no telling what could happen.

Hands-Free, but Not Worry-Free

With increased awareness of the dangers new technology can present, solutions like hands-free accessories have popped up. But the problem is far from solved. Much of the research on using hands-free technology has focused on use while driving, but the lessons learned are easily transferrable to nearly any situation. Even with a Bluetooth headset in his or her ear, a mobile device user is still distracted.

Removal: The Best Solution

The best practice is to eliminate the temptation to use mobile devices altogether and require your employees to either keep their phones in their pockets or, better yet, store them away from the hustle and bustle of the work site.

Practice what you preach. Job site foremen, managers, and other authority figures should model safe behavior, signaling to employees that casual use of mobile devices without a business purpose has no place on the job.

Keeping attention on this important topic is key. Post signs, dedicate a safety meeting to the subject — do whatever you can to let your employees know that mobile devices can be a threat to the safety of everyone on the site.

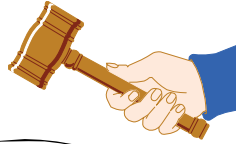

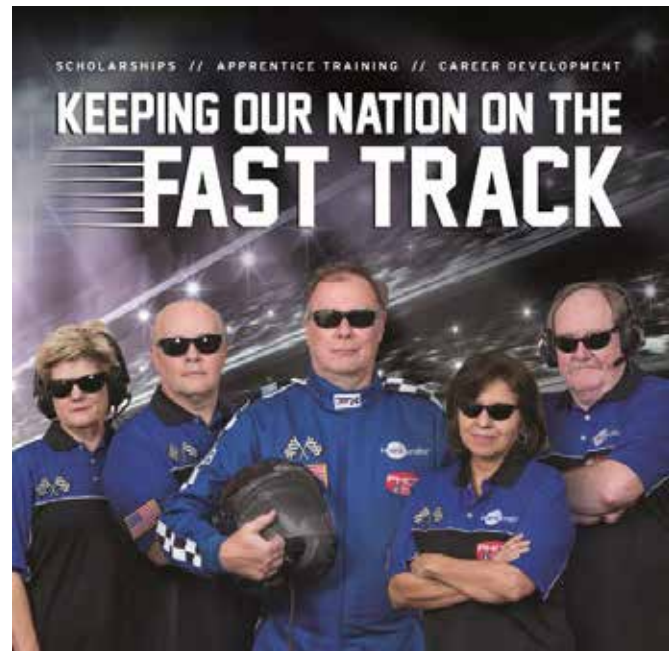

HEAT-RELATED ILLNESSES AND FIRST AID FROM OSHA

Heat stroke, the most serious form of heat-related illness, happens when the body becomes unable to regulate its core temperature. Sweating stops and the body can no longer rid itself of excess heat. Signs include confusion, loss of consciousness, and seizures. **Heat stroke is a medical emergency that may result in death! Call 911 immediately.**



the work—are usually the ones most affected by cramps. Cramps may occur during or after working hours.

Heat rash, also known as prickly heat, is skin irritation caused by sweat that does not evaporate from the skin. Heat rash is the most common problem in hot work environments.

The chart below shows **symptoms** and **first aid measures** to take if a worker shows signs of a heat-related illness.

Heat exhaustion is the body's response

to loss of water and salt from heavy sweating. Signs include headache, nausea, dizziness, weakness, irritability, thirst, and heavy sweating.



Heat cramps

are caused by the loss of body salts and fluid during sweating. Low salt levels in muscles cause painful cramps. Tired muscles—those used for performing

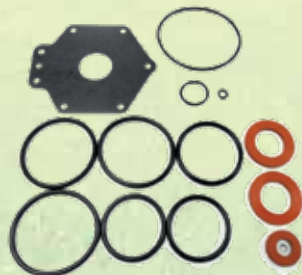
