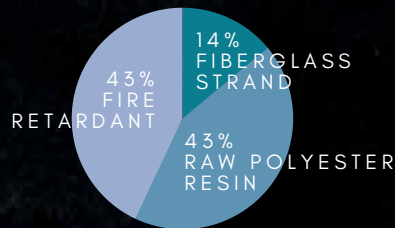

Booth Assignment: Management reserves the right to make all final decisions for booth assignment, layout, and configuration. Every effort will be made to assign the exhibitor's requested booth choices. Participation is at the sole discretion of Management and reserves the right to cancel any exhibitor.

Display Restrictions: All products, services, or literature displayed must fit within the allotted 8' x 10' booth space. Exhibits may not project beyond the space allotted or interfere with traffic, other exhibits, including line of sight. Exhibits may not extend into any aisle. Management reserves the right without recourse to prohibit any portion of any exhibit, which in its opinion is not suitable, or in keeping with the character of the event. This reservation of rights by Management applies to persons, things, conduct, printed matter, catalogs, and any other material relating to or affecting the event. No signs, banners, or flyers may be displayed or distributed outside of assigned booth space. The use of any public area outside of assigned booth space for the display of signage, solicitation, products, services, demonstrations, distribution of circulars, or other material is prohibited. 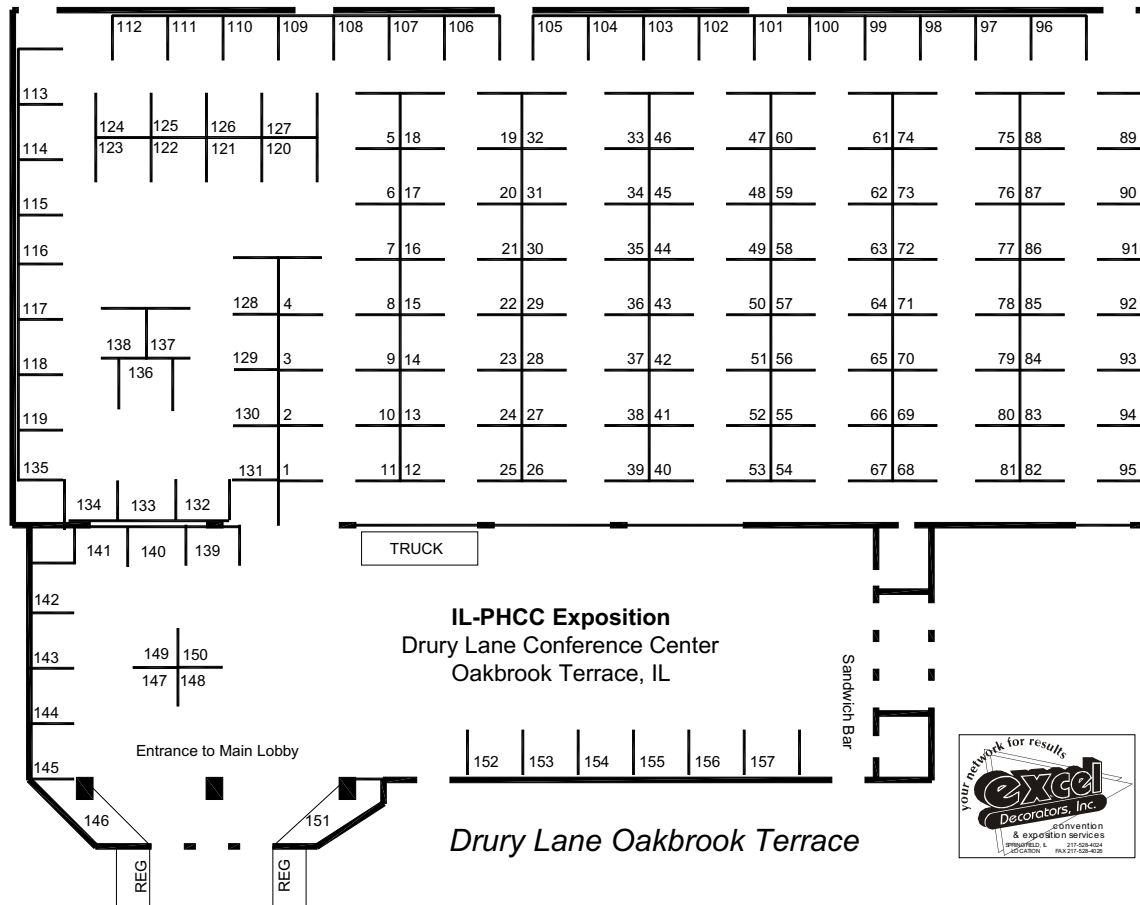
No Conflicts: There shall be no activities planned in conflict with this event.

MANDATORY SEXUAL HARASSMENT PREVENTION TRAINING

Public Act 101-0221 (commonly referred to as the Workplace Transparency Act), requires Illinois employers to provide sexual harassment prevention training to their employees on an annual basis, regardless of the size of the company.

Under this law, Illinois employers have until December 31st each year to train employees on sexual harassment prevention. The Act provides minimum standards that must be included in the training. To assist your business in complying with this new law, the Illinois Department of Human Rights has posted the following information on its website:

- A FAQ for Sexual Harassment Prevention Training
- Minimum Sexual Harassment Prevention Training Standards for All Employers

Employers must either develop their own sexual harassment prevention training program that equals or exceeds the minimum standards for sexual harassment prevention training outlined in Section 2-109(B) of the Illinois Human Rights Act, or they may use the model training provided by the IDHR. PCA MEMBERSHIP MEETING EXPLORED LEGISLATIVE TOPICS

A midday meeting featuring a program panel well-versed and experienced in legislative matters affecting the construction (and specifically plumbing) industry welcomed attendees to Shaw's Crab House in Schaumburg on September 14. The event opened with a networking reception, followed by a luncheon that led to the program.

Panelists included Illinois State Senator and Assistant Majority Leader Linda Holmes (District 42); IMSCA Executive Director Jessica Newbold-Hoselton and General Counsel James Rohlfing; and Illinois PHCC Chapter Executive Director Bev Potts. Moderating duties were handled Newbold-Hoselton and PCA Executive Director S.J. Peters.

Senator Holmes is the sponsor of IMSCA-initiated SB 178 pertaining to retainage reduction for public projects, and she was instrumental in the passage of favorable retainage reduction on private projects (SB 1636) in 2019. Newbold-Hoselton led a conversation with Senator Holmes on a variety of key topics including the defunct proposed repeal of the Prompt Pay Act; efforts toward prevailing wage expansion; public-private partnership; unemployment trust fund deficit; the redistricting process; and an overview of only the process on the vote for the proposed Illinois constitutional initiative known as the "Workers' Rights Amendment" which will be on the November 8 election ballot.

Potts next provided an overview and explanation of a half dozen legislative bills that had been proposed in the last session related to plumbing. While Potts showed which were beneficial to the industry, benign, redundant, or potentially harmful, none she covered at the meeting passed. However, the prospect of these bills being re-submitted is always a possibility.

Finally, an in-depth discussion was then led by Rohlfing, explaining HB 5412 (P.A. 101-1076), which makes prime contractors liable for paying subcontractors' workers' unpaid wages and fringe benefits. IMSCA was successful in adding language containing an exemption for union contractors. Rohlfing emphasized that the intent by the lawmakers (on record during the deliberation process before that bill became law) would very likely substantiate the exemption. A question & answer period with further comments and discussion concluded the meeting.

CHICAGO AREA PLUMBING INDUSTRY HONORS NEWEST “HALL OF FAME” INDUCTEES AT AUG. EVENT

The Chicago Training Center of the Plumbers’ Local 130 UA JAC was the ideal setting as over 125 industry well-wishers including member contractors, Association leaders, Union officials, invited guests, family and friends gathered on August 31, 2022 to pay tribute to the two newest inductees into the “Chicago Area Plumbing Industry Hall of Fame”: **Terrance M. McCarthy of Terry Plumbing Co. and George W. Treutelaar of Great Lakes Plumbing & Heating Co.**

Created in 2002 by the Plumbing Contractors Association Board (PCA), the Hall of Fame Committee has consistently selected individuals who have shown an abundance of personal commitment, professional dedication, ingenuity, integrity, and a passion to seek innovation and improvements to our industry. This year, as initiated by the PCA to ensure full participation of the entire Chicagoland jurisdiction, for the first time ever the selection committee was comprised of representatives of the PCA, Plumbers Local 130 UA, the West Suburban Association of Plumbing Contractors (WSA), the Kankakee & Iroquois Counties Plumbing & Piping Contractors Association, and the manufacturing/supply/rep component of our trade.

HR Question OF THE MONTH

UNAUTHORIZED OVERTIME?

Question

We have a problem with employees who clock in and start working before their shifts are scheduled to begin. They also continue working and clock out after their shifts are scheduled to end. As a result, these employees work over 40 hours a week and are entitled to overtime pay. We have a policy that specifically states that employees must receive prior approval before working any overtime. Can we refuse to pay these employees for the unauthorized overtime that they worked, since they violated our policy and did not receive prior approval? If not, what other recourse do we have?

ANSWER

In its Fair Labor Standards Act (FLSA) Hours Worked Advisor, the U.S. Department of Labor (DOL) provides that “[i]t is the duty of management to exercise control and see that work is not performed if the employer does not want it to be performed. An employer cannot sit back and accept the benefits of an employee’s work without considering the time spent to be hours worked.”

Thus, employers must timely pay all wages for hours that they know or should know employees worked. If employees clock in before their scheduled start times and start

working, this time is payable, even if it results in employees’ working when they are not supposed to and incurring unauthorized overtime in violation of company policy. The same rule applies if employees continue working and clock out after their scheduled end times. As the DOL notes in the guidance referenced above, “Merely making a rule against such work is not enough. The employer has the power to enforce the rule and must make every effort to do so.”

That said, as the DOL suggests, an employer is not without recourse. Employees who clock in before the start of their shifts, clock out after their shifts end, and/or incur unauthorized overtime can be disciplined for any such policy violations. However, the disciplinary action for these types of infractions must stop short of failing or refusing to pay wages (including overtime) that are otherwise due.

In sum, while employees can be disciplined for violating company policies relative to adhering to a specific schedule, any proposal to dock pay as a form of disciplinary action can lead to unpaid wage claims and penalties. Remember to check your state and local laws for any additional rules that may apply. 🚗
